Please find the Private Placement Overview attached as well as the NI 43101 TSX sanctioned geological study on the PGR reserve in the Holbrook Basin. The overview outlines the business case and the terms of the current private placement. Takeaways are we found a gross resource of 718 tons and 82mm tons of finished potash. Finished potash trades at roughly \$500 / ton today and is expected to average \$1500 / ton by 2020. The reserve speaks for a 50 - 60 year mine life. Please let me know if you have any questions.
