1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Preventing Anti-Se-
5	mitic Hate Crimes Act".
6	SEC. 2. FINDINGS.
7	Congress finds the following:
8	(1) Jews are the targets of the majority of hate
9	crimes committed in the United States against any

1	religious group, including attacks on houses of wor-
2	ship and Jewish community centers.
3	(2) Amid ongoing conflict in May 2021 between
4	Israel, which is one of the closest allies of the United
5	States, and Hamas, which is a terrorist organization
6	and has been designated by the United States as
7	such since 1997, media reports indicate that there
8	has been a dramatic increase in hate crimes and vio-
9	lence against Jews in the United States.
10	(3) Media reports indicate that activists and
11	mobs acting in support of the terrorist group
12	Hamas, and its sympathizers have incited and per-
13	petrated hate crimes and violence against Jews in
14	the United States in 2021.
15	(4) A recent survey conducted by the Anti-Def-
16	amation League indicates that 63 percent of Amer-
17	ican Jews have directly experienced or witnessed
18	anti-Semitic hate incidents within the past five
19	years.
20	(5) Anti-Semitism has long perpetrated myths
21	about Jews, including the Russian fabrication of the
22	Protocols of the Elders of Zion and the wide circula-
23	tion of libelous falsehoods about the Jewish murder
24	of infants.

1	(6) In its most extreme form, anti-Semitism
2	aims at the physical destruction of the Jewish peo-
3	ple, as seen in pogroms, forced conversions and Nazi
4	Germany's murder of over six million Jews.
5	(7) Anti-Semitism has included attacks on the
6	livelihood of Jews including prohibitions on land
7	ownership, campaigns to boycott, confiscate or de-
8	stroy Jewish businesses, and denial of the ability of
9	Jews to practice certain professions.
10	(8) In the United States, Jews have suffered
11	from systematic discrimination in the form of exclu-
12	sion from home ownership in certain neighborhoods,
13	prohibition from staying in certain hotels, restric-
14	tions upon membership in private clubs and other
15	associations, limitations upon admission to certain
16	educational institutions and other barriers to equal
17	justice under the law.
18	(9) In the United States, Jews have faced, and
19	continue to face, false accusations of divided loyalty
20	between the United States and Israel, false claims
21	that they purchase political power with money, and
22	false accusations about control of the financial sys-
23	tem, along with other negative stereotypes.

1	(10) The people of the United States stand in
2	solidarity with those affected by hate incidents di-
3	rected toward the American Jewish community.
4	SEC. 3. REVIEW OF HATE CRIMES.
5	(a) In General.—Not later than 7 days after the
6	date of enactment of this Act, the Attorney General shall
7	designate an officer or employee of the Department of
8	Justice whose responsibility during the applicable period
9	shall be to facilitate the expedited review of anti-Semitic
10	hate crimes (as described in section 249 of title 18, United
11	States Code) and reports of any such crime to Federal,
12	State, local, or Tribal law enforcement agencies.
13	(b) APPLICABLE PERIOD DEFINED.—In this section,

6	(1) In general.—Not later than 90 days after
7	the date of enactment of this Act, and every 90 days
8	thereafter until December 31, 2024, the Attorney
9	General shall issue a report to the appropriate con-
10	gressional committees summarizing—
11	(A) the number of hate crimes and other
12	incidents reported to the Federal Bureau of In-
13	vestigation during the preceding 90 days for
14	which the government has reason to believe that
15	the victim was targeted because he or she is
16	Jewish or was perceived to be Jewish;
17	(B) the number of active investigations
18	into anti-Semitic hate crimes, disaggregated by
