2 1 (2) Understanding the origins of the COVID-2 19 essential pandemic is to addressing our 3 vulnerabilities and preventing future crises. 4 (3) In May 2020, the World Health Assembly 5 did not authorize a comprehensive investigation into 6 the origins of COVID-19, and instead passed a sig-7 nificantly limited compromise resolution, with Chi-8 nese government support, which did not explicitly in-9 clude in its scope the possibility of a research-related 10 accident. 11 (4) The 2020 World Health Assembly resolu-12 tion and its terms of reference, which were nego-13 tiated privately between the World Health Organiza-14 tion (in this section referred to as "WHO") and Chi-15

nese authorities, handed the Chinese government control over the joint-study process by giving the Chinese government veto power over which international experts were allowed to participate in the joint study and by agreeing that most primary research would be carried out by Chinese teams without ensuring broad access to primary data by international experts.

(5) As a result of these terms, the significant structural, procedural, and analytical shortcomings of the joint study, and the severe restrictions imMUR21421 FML S.L.C.

posed by Chinese authorities, the WHO-convened joint study into the origins of COVID-19 was prevented from providing a balanced consideration of the multiple theories of the origin of COVID-19.

- (6) Only 4 of the 313 pages of the joint-study team report and its annexes addressed the possibility of a laboratory accident, and no thorough examination of the lab incident hypothesis was carried out by the joint-study team.
- (7) Some of the international experts on the joint-study team stated that they lacked the means and resources to properly investigate the research-related accident hypothesis, and they were neither able nor meant to do such a full investigation but instead were acting as a "study review group".
- (8) WHO Director-General Dr. Tedros Adhanom Ghebreyesus commented on March 30, 2021, the day the joint-study report was released, "I do not believe that [the joint-study team's] assessment [of a possible lab incident] was extensive enough. Further data and studies will be needed to reach more robust conclusions . . . potentially with additional missions involving specialist experts, which I am ready to deploy.".

1	(9) The WHO Director-General further com-
2	mented, "As far as WHO is concerned all
3	hypotheses remain on the table We have not
4	yet found the source of the virus, and we must con-
5	tinue to follow the science and leave no stone
6	unturned as we do It is clear that we need
7	more research across a range of areas, which will en-
8	tail further field visits.".
9	(10) The March 30, 2021 Joint Statement on
10	the WHO-convened COVID-19 Origins Study by the
11	United States and 13 other countries recognized the
12	severe shortcomings of the joint-study process and
13	called for "a transparent and independent analysis
14	and evaluation, free from interference and undue in-
15	fluence.".
16	(11) In spite of the devastation the COVID-19
17	pandemic has caused in the United States and
18	around the world, no process currently exists to en-
19	sure a comprehensive investigation into the source of
20	COVID-19.
21	(12) Such an investigation is essential for en-
22	suring this type of crisis never happens again for the
23	benefit of all people, all nations, and future genera-
24	tions.

1 (b) SENSE OF THE SENATE.—It is the sense of the 2 Senate that— 3 (1) a comprehensive investigation to determine 4 the origins of COVID-19 must be conducted by 5 WHO immediately, with access to all relevant 6 records, samples, and personnel in China, and that 7 such investigation must fully explore all possible 8 sources of the COVID-19 pandemic, including exclu-9 sively "natural" zoonosis in the wild, human con-10 tamination in an animal farm, and a research-re-11 lated accident; 12 (2) the United States delegation to the World 13 Health Assembly should, in concert with allies and 14 partners around the world, work to ensure that an 15 international scientific investigation into the origins 16 of COVID-19, with full access to all relevant 17 records, samples, and personnel in China, will be au-18 thorized by the World Health Assembly and imple-19 mented with extreme urgency; and 20 (3) should such a full investigation not be au-21 thorized by the 2021 World Health Assembly, then 22 the United States Government should immediately 23 begin planning a comprehensive and data-driven in-24 vestigation into the COVID-19 pandemic origins, in
