To make certain members of the Chinese Communist Party
ineligible for F or J visas, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protecting Higher

5 Education from the Chinese Communist Party Act of

6 2022”.

1 **SEC. 2. INELIGIBILITY FOR CERTAIN VISAS OF MEMBERS**
2 **OF THE CHINESE COMMUNIST PARTY.**

3 (a) **GROUND FOR EXCLUSION.**—An alien may not
4 be accorded status or receive a visa under subparagraph
5 (F) or (J) of section 101(a)(15) of the Immigration and
6 Nationality Act (8 U.S.C. 1101(a)(15)) if the alien is a
7 person who is, as of the date of enactment of this Act
8 or at any time thereafter—

9 (1) a member of the Chinese Communist Party
10 (hereinafter referred to as the “CCP”) who has
11 served on the National Congress of the Chinese
12 Communist Party or other position, including—

13 (A) General Secretary of the CCP;

14 (B) a member of the Secretariat of the
15 CCP;

16 (C) a member of the Political Bureau
17 Standing Committee;

18 (D) a member of the Political Bureau of
19 the CCP Central Committee;

20 (E) a member of the CCP Central Com-
21 mittee;

22 (F) a member of the Central Military
23 Commission;

24 (G) a member of the Central Commission
25 for Discipline Inspection; or

1 (H) a member of the National People's
2 Congress; or

3 (2) a family member of a person described in
4 paragraph (1).

5 (b) FAMILY MEMBER.—For purposes of this section,
6 the term “family member” means, with respect to a per-
7 son, that person’s spouse, child, parent, sibling, or grand-
8 child.

9 (c) EXCEPTION TO COMPLY WITH UNITED NATIONS
10 HEADQUARTERS AGREEMENT.—Subsection (a) shall not
11 apply to an individual if admitting the individual to the
12 United States is necessary to permit the United States
13 to comply with the Agreement between the United Nations
14 and the United States of America regarding the Head-
15 quarters of the United Nations, signed June 26, 1947,
16 and entered into force November 21, 1947, and other ap-
17 plicable international obligations

18 (d) NATIONAL SECURITY WAIVER.—The President,
19 or a designee of the President, may waive the application
20 of subsection (a) if the President or such designee certifies
21 in writing to the appropriate congressional committees
22 that such waiver is in the national security interest of the
23 United States.
