  - 3 SECTION 1. SHORT TITLE.

2	ACTIONS BY CFIUS.
3	(a) In General.—Section 721 of the Defense Pro-
4	duction Act of 1950 (50 U.S.C. 4565) is amended—
5	(1) in subsection $(a)(5)$ —
6	(A) by striking "means, subject" and in-
7	serting the following: "means—

9	(B) by striking the period at the end and

6	a prohibited country may not carry out any merger,
7	acquisition, or takeover that could result in foreign
8	control of a United States agricultural company.
9	"(2) Prohibited Country.—In this sub-
10	section, the term 'prohibited country' means each of

14	"(C) Iran.
15	"(D) North Korea.".
16	(b) Report Required.—Not later than 180 days
17	after the date of the enactment of this Act, and every 180
18	days thereafter, the Secretary of Agriculture shall submit
19	to the Committee on Agriculture of the House of Rep-
20	resentatives and the Committee on Agriculture, Nutrition,
21	and Forestry of the Senate a report on the risks that for-
22	eign purchases of agricultural companies pose to the agri-
23	cultural sector of the United States.
